This rule sets forth managed care plan (MCP) and primary care physician (PCP) responsibilities for care coordination. The changes to the rule add language to clarify utilization management criteria and add a provision which allows prior authorization timeframes to be increased from five working days to fourteen calendar days (except for pharmacy prior-authorizations).
