This rule sets forth the services that managed care plans (MCPs) are required to provide to Medicaid managed care consumers. The changes to the rule specify the circumstances under which a Medicaid MCP is permitted to refer its members to a non-contracting hospital for non-emergency hospital services. The changes to the rule add language requiring non-contracting hospitals to accept the Medicaid fee-for-service rate for non-emergency hospital services when authorized by ODJFS. A provision was also added to this rule to require MCPs to pay non-contracting hospitals for all emergency services regardless of whether the services meet an emergency medical condition definition.
