The rule amendments also reference the new "Ohio Department of Mental Health and Addiction Services" being established on July 1, 2013. Additionally, language was added to change the department's name from the "Ohio Department of Job and Family Services (ODJFS)" to the "Ohio Department of Medicaid (ODM)."
