This rule sets forth the covered services that Medicaid managed care plans are required to provide to Medicaid managed care members.

The rule is being amended to add respite services for Medicaid children enrolled in Medicaid managed care plans who are under the age of 21 years and eligible for Supplemental Security Income (SSI). "Respite services" are services that provide short-term, temporary relief to an informal unpaid caregiver of an individual under the age of 21 in order to support and preserve the primary caregiving relationship. Other amendments clarify language describing the obligations of MCPs regarding payment for emergency conditions and update cross-references and legal citations.
