To clarify requirements for managed care plan (MCP) provider panels and subcontracts, needed to implement the mandates of R.C. 5111.0112, 5111.16, and 5111.162, as amended by Am. Sub. HB 66.

This rule sets forth requirements for managed care plan (MCP) provider panels and subcontracts. The changes to the rule add language stating that unless otherwise specified by ODJFS, any information submitted to ODJFS regarding services rendered by a delegated entity, must be submitted directly by the MCP. The changes to the rule also clarify and add additional MCP subcontracting requirements.
