To implement provisions of RC 3963.05 and 3963.06 relating to the administration of Managed Health Care Programs, and RC 5111.17 relating to the administration of Medicaid Managed Health Care Programs, adopted under Substitute House Bill 125 of the 127th General Assembly.

This rule sets forth requirements for managed care plan provider panels and subcontracts. The changes to the rule remove a requirement that managed care plans obtain agency prior-approval of panel providers. The changes to the rule also update a cross reference to the Ohio Revised Code.
