This rule is being proposed for amendment to clarify language related to the Medicaid managed care plan (MCP) grievance system.

This rule sets forth MCP grievance system requirements. The changes to the rule

add federally-required language regarding information that must be contained on managed care plan (MCP) member appeal notifications. The changes to the rule also include clarification that the ninety day period for member appeals begins the day after the mailing date of the notice of action and that MCPs are to submit information regarding grievance and appeal activity as directed by ODJFS.
