This rule sets forth the requirements for managed care plan (MCP) non-contracting providers. The changes to the rule add language to clarify the definition of a non-contracting provider. Language was also added to reduce the Medicaid rate paid by MCPs to non-contracting providers of emergency services by any payments for indirect costs of medical education and direct costs of graduate medical education.
