The following technical changes were made to the proposed rule:

Paragraph (A) added "as amended" to Social Security Act;

Paragraph (C) (1) (c) defined acronym for ICF-MR/DD LOC "intermediate care facility for the mentally retarded developmentally disabled level of care";

Paragraph (C) (3) defined acronym for ICF-MR as "intermediate care facility for the mentally retarded."
