The rule is being filed in accordance with the five year rule review process.

This rule sets forth the PAS requirements which must be met prior to any new admission to a NF or enrollment in the PASSPORT HCBS waiver. Changes from the previous version of this rule are related to revisions to the definitions section located in paragraph (B) which include changes to inpatient psychiatric stays, new admission parameters, current diagnoses, and the definition of physician. In addition, multiple changes to the process are found throughout the rule as is language meant to clarify current process and practice.

The following revisions are being made in response to comments received during the clearance process and from other interested parties: Language was added to paragraph (B)(11)(e) to clarify that this provision does not apply to nursing facilities that already have their Medicaid certification and are undergoing a change of

ownership or operator; A quotation mark was moved to the right of (PAS/ID) in the first sentence of paragraph (B)(14); In paragraph (B)(19) "or another licensed health care professional whose scope of practice includes diagnosis" was added to the definition of primary diagnosis; and in paragraph (D)(6) the length of time an unused PAS determination remains valid was changed to sixty days from thirty days.

There is an impact of the rule changes on the industry. Late detection of a facility's failure to complete the preadmission process in compliance with federal regulations and state rules results in facility liability until it is completed. Facility costs may range from \$150 to \$30,000 per incident according to the industry.
