This rule is being adopted as part of a reorganization of rules administered by the Bureau of Long Term Care Facilities.

then summarize the content of the rule:

This rule contains the bed-hold provisions for nursing facilities (NFs).

It replaces rule 5101:3-3-59, which is being proposed for rescission.

Changes from the rescinded rule include: definitions in paragraph (A) that are specific to nursing facility residency have been clarified, and "NF therapeutic leave day" has been added to the terms defined; a new provision in paragraph (B) prohibits preadmission bed-hold payments; paragraph (D)(4) contains a new provision stating that the number and frequency of bed-hold days used shall be considered when evaluating a resident's continuing need for NF care; paragraph (E) contains new provisions regarding electronic submission of bed-hold payment requests; paragraph (F)(2)(b) specifies the admission policy for a resident with exhausted bed-hold days in the context of a properly processed prior involuntary discharge; paragraph (F)(3)(b) clarifies the relationship of self-paid bed-hold payments to third-party bed-hold payments; in paragraph (J)(5), qualified medicare beneficiary (QMB) eligible residents have been added to the categories of residents for whom NF providers may receive bed-hold payments; paragraph (L) adds provisions regarding provider compliance with bed-hold restrictions and requirements; and the Appendix to this rule, "Nursing Facility Bed-Hold Days," has been removed.
