This rule is being proposed for permanent amendment in accordance with Section 10 of Amended Substitute Senate Bill 261 of the 124th General Assembly by increasing the mean total per diem rate utilized in the NFs expenditure limitation calculation for fiscal year 2003, from one hundred fifty-two dollars and sixty-six cents to one hundred fifty-three dollars and forty-one cents, and to comply with Revised Code 119.032

This rule sets forth a total per diem rate expenditure limitations for NFs for fiscal year 2002 and 2003.
