This rule sets forth the requirements for a provider to be eligible to be reimbursed for providing Medicaid community alcohol and other drug treatment services. This rule is being amended to limit the requirement that providers must contract with a community alcohol and other drug addiction board to only those services rendered prior to July 1, 2012. After this date a contract with the board will not be necessary to be reimbursed for Medicaid services. Additional revisions are included to update the rule as needed.
