This rule is being proposed for amendment in order to implement a policy change in HB 153 (129th GA) that modified the home first program for PASSPORT program enrollments.

This rule defines the terms used in Chapter 5101:3-31 of the Administrative code for the PASSPORT program.

The rule is being amended to:

- 1) Add a definition for "case management";
- 2) Update the ORC citation in paragraph (O)(1) to reflect the Ohio department of Mental Health's responsibility for certifying adult foster homes;
- 3) Add a definition for "home first"; and
- 4) Delete the definition of "SSI" as that term is not used in the chapter.

3. Add language to clarify that a consumer's service plan is a person centered document.
