The rule as amended clarifies that, pursuant to the waiver, meeting the individual cost limit on services is a criteria for application and enrollment. The proposed rule

also states that the cost of care for a consumer already enrolled on the waiver may, with supervisory approval, exceed the cost limit up to 100 per cent of the total Medicaid cost for nursing facility services.

In addition, the rule also contains new language stating that PASSPORT consumers must require the provision of at least one PASSPORT waiver service per month.

Lastly, the rule establishes that individuals receiving hospice services before PASSPORT enrollment are not eligible to enroll in the PASSPORT program; however, individuals enrolled in PASSPORT may receive hospice services if those services are provided to consumers while on the waiver.
