**PASSPORT HCBS waiver rate setting.****RULE SUMMARY**

Five-year review. To update and clarify the preadmission screening system providing options and resources today (PASSPORT) home and community based services (HCBS) waiver program rates.

This rule sets forth the description of the methods used to determine provider rates

for the preadmission screening system providing options and resources today (PASSPORT) home and community based services (HCBS) waiver program.

Changes to this rule include the addition to the opening paragraph "The requirements pertaining to services directed by waiver consumers set forth in this rule begin when the Ohio department of job and family services (ODJFS) receives approval from the centers for medicare and medicaid services (CMS) of an amendment adding consumer direction to the PASSPORT waiver, or on the effective date of this rule, whichever is later."

Changes to paragraphs (E) are being proposed to reflect that a single rate will be set by ODA for each service listed. This paragraph also reflects the addition of a new provider type to PASSPORT (individual providers) and the addition of a new service (enhanced community living). Paragraph (E) now also lists the waiver's emergency response system service (ERS), which results from a change in rate methodology as the rule currently indicates that ERS rates are set on a regional basis.

There is no change in rate setting proposed for those services listed in paragraph (F). The rates for those services will continue to be set by ODA on a regional basis. Changes reflect formatting updates.

No service may have a unit rate that exceeds the Medicaid maximum set by ODJFS in rule 5101:3-1-06.1 of the Administrative Code.
