The purpose of this rule is to establish how the rates of reimbursement are set for Choices waiver services.

The rule is being amended to:

- 1) Clarify the purpose of the rule;
- 2) Add language requiring Choices providers be certified by the Ohio Department of Aging (ODA) with a valid Medicaid provider agreement;
- 3) Add language to specify the services in which Choices consumers may negotiate rates of reimbursement with their providers;
- 4) Modify the required elements of the agreement signed between the Choices consumer and their home care attendant service (HCAS) provider;
- 5) Establish that for certain services, rates will be set using the methodology in rule 5101:3-31-07 (PASSPORT rate setting) of the OAC.

Beginning July 1, 2011, the legislature appropriated funds directly to ODJFS to pay for Choices waiver services and local administration. Previously, the Ohio Department of Aging received this appropriation in its budget. The funding appropriated to ODJFS assumes the reimbursement changes contained in this rule are effective on July 1, 2011. Implementing this change will not impact ODJFS' expenditures on Choices waiver services; however ODJFS estimates that the proposed amendments to this rule will reduce Choices waiver program expenditures by approximately \$655.00 in SFY 2012 and \$655.000 in SFY 2013.

The changes in this rule reduce Medicaid reimbursement to providers.
