The purpose of the rule is to outline the criteria that must be met for an individual to be eligible to enroll in the Assisted Living Home and Community Based Services (HCBS) Waiver. The changes are intended to expand the pool for eligible participants by including current residents of a residential care facility and to remove eligibility criteria for an unschedulable need with two activities of daily living.

This rules is being amended to expand the Assisted Living Waiver to include residents of a residential care facility (RCF) that resided in the RCF for 6 months immediately before the date the individual applies for the Assisted Living Waiver. Additionally, this rule is also being amended to require that as a condition of eligibility, it must be determined by the PASSPORT Administering Agency (PAA) in which the consumer is applying for the Assisted Living Waiver that the consumer's needs can be met through this waiver.

This rule is also being amended to expand the targeting criteria for participants by making the criteria less restrictive for an un-schedulable need with two activities of daily living.

Pending approval from the Centers for Medicare and Medicaid Services (CMS), the changes proposed to this rule are consistent with the federally approved waiver.
