The rule is being amended to:

- 1) Replace the word "rules" with "rule" and the use the acronym "HCBS" instead of "home and community based services" in paragraph (A);
- 2) Update OAC citation in paragraph (B) relative to provider certification; and
- 3) Establish that consumers have free choice of qualified provider in the Assisted Living waiver program as set forth in 42 C.R.F. 431.51.
