1) Specify that Assisted Living waiver program's maximum reimbursement rates are in rule 5101:3-1-06.5 of the Administrative Code;

- 2) Clarify that rates are determined as either a "unit rate" or "per job bid rate or deposit made";
- 3) Specify that the waiver's community transition service is to be reimbursed at a per job bid rate or deposit made;
- 4) Specify that the waiver's assisted living service is to be reimbursed at a unit rate; and
- 5) Clarify that the Assisted Living waiver program provider must agree to provide the services in the consumer's service plan.
