This rule is being amended to incorporate policy changes associated with the adoption of the NPI requirements and as a result of an amendment to Ohio Administrative Code (OAC) rule 5101:3-1-17 entitled "Eligible providers [except intermediate care facilities for the mentally retarded (ICFs-MR) and Medicaid contracting managed care plans (MCPs)]."

This rule outlines coverage provisions for eligible providers of physician services. The definition of a "physician group practice" has been revised. A physician group practice is considered a business enterprise that consists of two or more physicians, or a single physician who is incorporated, enrolled in the Medicaid program for the purpose of providing physician services. Another proposed change found in paragraph (A)(2)(a), is the removal of "a foundation" as a valid physician group practice arrangement.
