To update policy governing the provision of physician services in the Medicaid program. This rule is replacing rescinded rule 5101:3-4-01.

This rule defines the term "physician," lists those eligible Medicaid providers that

can be providers of physician services, and sets forth certain reimbursement requirements and restrictions. Differences between this rule and the rule it replaces are that (1) the list of providers of physician services is expanded to include optometrists and (2) the entire text of the rule is reorganized and streamlined. Classifying services provided by optometrists as physician services will enable optometrists to benefit from certain provisions of the American Recovery and Reinvestment Act of 2009 that establish incentive payments for the adoption and meaningful use of certified electronic health record (EHR) technology.
