This rule is being proposed for amendment to announce the adoption of the 2009 Healthcare Common Procedure Coding System (HCPCS) and 2009 Current Procedural Terminology (CPT) codes effective January 1, 2009, in order to maintain consistency with industry standards, which the Ohio Department of Job and Family Services is required to do under the Health Insurance Portability and Accountability Act (HIPAA), pursuant to 45 CFR 162.1000 and 45 CFR 162.1002.

of the proposed rule; If the rule type is RESCISSION, NEW or NO CHANGE, then summarize the content of the rule:

This rule defines what constitutes a physician visit and sets forth criteria for submitting claims to Medicaid. Changes include updating the references to HCPCS codes to reflect those in the "Health Care Common Procedure Coding System HCPCS 2009" (1/09 edition) published by the American Medical Association. References to the "Health Care Common Procedure Coding System HCPCS 2008" (1/08 edition) are replaced with references to "Health Care Common Procedure Coding System HCPCS 2009" (1/09 edition). The codes found in the replacement references are effective for dates of services January 1, 2009 through December 31, 2009.
