This rule outlines the services related to physician visits. It covers definitions of

visits and limitations, consultations, critical care, nursing facility visits, home services, emergency department services, and inpatient/outpatient visits.

Multiple changes were made to this rule due to code changes in the evaluation and management portion of the CPT manual. Codes for confirmatory consultations have been deleted and providers are to bill appropriate consultation codes. Categories for low birth weight infants have been revised to allow for new weight ranges. Codes for nursing facility services have been revised to include new criteria to bill for certain codes. Finally, the codes for after hours care have been changed. The only code available to providers to bill for after hours care will be 99050. The rest of the codes for after hours care will not be covered by the Department.
