Providers are required to submit claims in order to receive Medicaid reimbursement. On each claim, a provider reports many pieces of information, such as the identity of the person served, the services provided, related diagnoses, the date of service, and the place of service.

Rule 5101:3-4-06 also has particular reporting requirements: (1) Many portions of the rule specify which procedure codes providers must report on claims. (2) For consultation services, providers must submit information about the referring physician, and for hospital observation services, they must report certain information about the hospital admission.
