The Vaccines for Children (VFC) Program was created by Congress in 1993 following a measles epidemic resulting in tens of thousands of cases of measles and hundreds of deaths. More than half the children who had measles had not been immunized. The Advisory Committee on Immunization Practices (ACIP) approves which vaccines are available through the VFC program. Section 1905(r)(1) of the Social Security Act, 42 U.S.C. 1396d(r)(1), provides that screening services for all Medicaid recipients under the age of 21 shall include appropriate immunizations, to be provided according to the recommendations of the ACIP. Recently, ACIP has approved three new vaccines for the VFC program, and rule 5101:3-4-12 is being

amended to include these new vaccines.

5101:3-4-12 sets forth the coverage and reimbursement policy for immunizations within the Ohio Medicaid program. The rule identifies those vaccines which are covered by the Vaccines for Children Program and those which are not and provides guidance on billing in either instance.

5101:3-4-12 is being amended to add three new vaccines which will be available through the Vaccines for Children program operated by the Ohio Department of Health. The new vaccines and their procedure codes are: 90681 - Rota (Rotavirus vaccine, live, oral); 90696 - DTaPIPV (diphtheria and tetanus toxoids and acellular pertussis adsorbed and inactivated poliovirus vaccine); and 90698 - DTaPIPHI (diphtheria and tetanus toxoids and acellular pertussis adsorbed, inactivated poliovirus and haemophilus b conjugate). An additional change is changing the URL for the Centers for Disease Control's website referenced in paragraph (B)(1)(c)(i).

The three new vaccines which are being added to this rule are part of the Vaccines for Children Program and are available free to participating providers through the Ohio Department of Health. The Ohio Medicaid program reimburses those providers a fee of \$10.00 for administering the vaccine to Medicaid eligible children. The three new vaccines will offset the usage of other existing vaccines. Consequently, no new cost of compliance is associated with the proposed rule amendment.
