Several changes have been made to this rule due to a change in policy. The title of the rule was changed to Therapeutic injections (including trigger point injections) and prescribed drugs. Language was added to the rule covering the guidelines for the administration and reimbursement of Current Procedural Technology (CPT) codes used for trigger point injections. The policy will limit the use of trigger point injections to a total of eight sessions in a twelve month period, and contain provisions for more specific documentation on the the treatment.
