This rule is being proposed for amendment to announce the adoption of 2008 Healthcare Common Procedural Coding System (HCPCS) and 2008 Current Procedural Terminology (CPT) codes effective January 1, 2008 in order to maintain consistency with industry standards, which the department is required to do under the Health Insurance Portability and Accountability Act (HIPPA).

This rule outlines coverage provisions for therapeutic injections (including trigger point injections) and prescribed drugs. The changes include expanding the Current Procedural Terminology (CPT) code range for therapeutic, prophylactic, or diagnostic injections to 90765 to 90779. In paragraph (A)(3)(v) deleting miscellaneous CPT code 90799 because this code is no longer considered a valid code by the American Medical Association, and replacing this code with miscellaneous CPT code 90779. Paragraph (B)(2) has been updated to include a physician visit for a patient will not be separetely reimbursed when performed on the same date of service as trigger point injection procedures.

Every year HCPCS is updated with new and deleted codes. Providers are required to use this coding system when billing for professional services. In order to comply with this rule providers are required to use the updated billing codes and may incur costs associated with updating the billing software. Due to providers using different software packages to create invoices, we are unable to provide an estimated cost to providers. The cost described is not a new cost and would be required by all payers, not just Medicaid. In addition, Medicaid reimbursement rates were developed to include administrative costs such as these. This rule maintains the current practice of providers updating their billing systems on an annual basis so there should be no new cost to providers.
