This rule is being proposed for amendment to announce the adoption of the 2009 Healthcare Common Procedure Coding System (HCPCS) and 2009 Current Procedural Terminology (CPT) codes effective January 1, 2009, in order to maintain consistency with industry standards, which the Ohio Department of Job and Family Services is required to do under the Health Insurance Portability and Accountability Act (HIPAA), pursuant to 45 CFR 162.1000 and 45 CFR 162.1002.

This rule sets forth coverage provisions for these services provided by physician providers of Medicaid services. Changes include the deletion and replacement of Healthcare Common Procedure Coding System (HCPCS) codes. In paragraph (A)(3)(b)(v) of this rule, the code 90779 was deleted and replaced by code 96379. This CPT code is for an unlisted therapeutic, prophylactic, or diagnostic injection or infusion. In paragraph (A)(4) of this rule, the span of codes 90765 to 90779 was deleted, and replaced by codes 96360 and 96361 and those ranging from 96365 to 96379 in two sentences. These CPT codes are for intravenous and subcutaneous infusions for therapy or prophylaxis, or diagnosis and for therapeutic, prophylactic, or diagnostic injections.
