This rule is being proposed due to the implementation of the new Medicaid Information Technology System (MITS) implementation.

This rule sets forth coverage of therapeutic injections and prescribed drugs. Language specifying how information about miscellaneous drugs should be entered on a claim has been revised. A clarification has been added to the prohibition against billing CPT codes 20552 and 20553 for the same patient on the same date of service. Language regarding prescribed drugs for take-home use has been removed.
