This rule is being proposed to amend language that will not be compliant with the new Health Insurance Portability & Accountability Act of 1996 (H.I.P.A.A.).

Local level code X9070 is not HIPAA compliant and codes A4580 and A4590 will no longer be covered Medicaid services. These codes will be replaced with the

range Q4001 to Q4048 (coverage for casting supplies).

Also, additional language was added to the rule to explain that conscious sedation is bundled into the payment for the related surgical or radiological procedure and is not separately reimbursable.
