The Adult Foster Care waiver service is projected to save the Ohio Department of Mental Retardation (ODMRDD) approximately \$16 million annually. Adult Foster Care will be provided in lieu of Homemaker Personal Service Care (HPC) which was projected to cost \$39 million to serve 633 individuals annually.
