The proposed rule establishes the IO waiver as a component of the Medicaid home and community-based services program in the modified format due to the renewal of the waiver program. The primary change to this waiver program is that waiver participants shall be subject to a cost limitation for waiver services which shall be administered on a statewide basis. The provisions set forth the application for waiver services; eligibility criteria; enrollment, continued enrollment, and disenrollment of waiver participants; waiver program benefit package and statewide individual benefit cost limitations; service planning requirements; free choice of provider provisions; requirements pertaining to the provision of IO waiver services; provider contracting requirements; reference to the appropriate payment standards Ohio Administrative Code rule; provider complaint and dispute resolution; monitoring, compliance and sanctions; due process requirements; and designation of local state matching funds.
