This rule will authorize the Level 1 waiver program as a component part of the medicaid home and community-based services program, operated by the Ohio department of mental retardation and developmental disabilities. It is filed to incorporate new waiver services to be in effect as of July 1, 2005, specifically day habilitation and supported employment services previously funded by the Community Alternative Funding System (CAFS). It also includes new language about the evaluation of enrollees' need for services when the enrollee has not used

any waiver services for a period of ninety days.

This rule authorizes the Level 1 waiver program as a component part of the medicaid home and community-based services program, and its operation by the Ohio department of mental retardation and developmental disabilities. It incorporates the eligibility requirements, enrollment and disenrollment processes, services allowable and benefit limitations, payment standards, service plan requirements, free choice of provider requirements, quality and service monitoring, and due process requirements of the program. It includes new language about the evaluation of enrollees' need for services when the enrollee has not used any waiver services for a period of ninety days, revises the process by which enrollees may obtain services beyond the benefit limitations, and removes references to federally noncompliant medicaid local administrative authorities and contracts.
