This rule is being created as part of the state's redesign of the Ohio Home Care Program. Specifically it is intended to more clearly delineate what a provider can and cannot do while providing services to consumers enrolled on an ODJFS-administered waiver. It will also serve to strengthen ODJFS' program monitoring capabilities.

This new rule sets forth the conditions of participation for all ODJFS-administered HCBS waiver service providers, including Medicare-certified, and CHAP and JCAHO-accredited home health agencies, and independent nurses, independent daily living aides and independent daily living non-aides.
