Changes include: replacing language requiring "a face-to face interview between the applicant and ODJFS or its designee" with language requiring "an assessment of the consumer's care needs in the community"; and adding language to clarify that eligibility for the Ohio Access Success Project is contingent upon, among other things, an individual's ineligibility for the HOME Choice (Money Follows the Person) Demonstration Program, as well as other services similar to the Ohio Access Success Project that are funded by the Ohio Medicaid Program.
