Five-year review. This rule is being proposed to update policies and to clarify language governing the Ohio Access Success Project, some of which relates to Ohio's HOME Choice (Money Follows the Person) Demonstration Program.

This rule sets forth the application process, eligibility requirements and benefit

limitations for the Ohio Access Success Project.

Changes include: replacing language requiring "a face-to face interview between the applicant and ODJFS or its designee" with language requiring "an assessment of the consumer's care needs in the community"; and adding language to clarify that eligibility for the Ohio Access Success Project is contingent upon, among other things, an individual's ineligibility for the HOME Choice (Money Follows the Person) Demonstration Program, as well as other services similar to the Ohio Access Success Project that are funded by the Ohio Medicaid Program.
