This rule is being proposed to implement part of the Money Follows the Person (MFP) HOME Choice (Helping Ohioans Move, Expanding Choice) Demonstration Program that is being created in response to Ohio's receipt of an MFP demonstration grant from the Centers for Medicare and Medicaid Services (CMS), and to implement Revised Code section 309.30.70 adopted under Am. Sub. H.B.

119, 127th General Assembly relating to MFP and budgeted in the GRF 600-525 account.

This rule contains key definitions associated with the HOME Choice Demonstration Program.

This rule is being refiled to indicate in the opening paragraph that the requirements of the rule begin when ODJFS receives approval of the HOME Choice Demonstration Program from the Centers for Medicare and Medicaid Services (CMS), or on the effective date of the rule, whichever is later. Additionally, the terms "HOME choice demonstration program consumer" and "HOME choice demonstration program consumers" have been changed to "HOME choice demonstration program participant" and "HOME choice demonstration program participants," respectively. The definition of "CMS," former paragraph (K), was removed because it is now referred to in the opening paragraph of the rule. In renumbered paragraph (K), "medicaid local administrative agency" was changed to "local medicaid administrative agency." The definition of "financial management services" in paragraph (M) was changed to "federally-mandated administrative services that an ODJFS-designated governmental entity and/or another ODJFS-designated third-party entity perform on behalf of the HOME choice demonstration program participant." The words ""as appropriate" have been removed from the definitions of "group rate" and "group setting" in paragraphs (N) and (O). The term "HOME choice demonstration program care coordinator" in paragraph (T) was removed because it was listed twice. The words "intermediate care facility for persons with mental retardation" were removed from the definition of "institutional setting" in paragraph (AA). The definition of "ODJFS," former paragraph (LL), was removed because it is now referred to in the opening paragraph of the rule. The definition of "ODJFS HOME choice demonstration program care coordinator" in paragraph (KK) was changed to "A person employed by ODJFS for the purpose of providing case management and care coordination services to HOME choice demonstration program participants who are not enrolled on an HCBS waiver." Within the definition of "qualified residence," paragraph (SS)(2)(c) was changed to "residential care facility units designated for assisted living that meet the requirements of paragraph (SS)(2) of this rule; or." The definition of "transition coordination services," former paragraph (CCC), was removed.
