This rule is being amended to clarify policy related to the implementation of the Money Follows the Person (MFP) HOME Choice (Helping Ohioans Move, Expanding Choice) Demonstration Program that was created in response to Ohio's receipt of an MFP Demonstration Grant from the Centers for Medicare and Medicaid Services (CMS), and implemented in accordance with Revised Code 309.30.70, adopted under Am. Sub. H.B. 119, 127th General Assembly and

budgeted in the GRF 600-525 account.

7. If the rule is an AMENDMENT, then summarize the changes and the content of the proposed rule; if the rule type is RESCISSION, NEW or NO CHANGE, then summarize the content of the rule:

This rule sets forth the codes and reimbursement rates for HOME Choice Demonstration Program services. Paragraph (A)(7) is being amended to rename "maximum hours/days" to "maximum usage amounts, and to reflect this change in paragraph (B), Table B, Column 6. Paragraph (F) is being amended to remove reference to the Medicaid reimbursement rule, and to set forth specific non-Medicaid reimbursement criteria. Paragraph (B), Table B, Column 4 and paragraph (F)(6) are being amended to establish the maximum reimbursement allowed for community transition services (i.e., goods and services) when the HOME Choice Demonstration Program participant is enrolling on a waiver administered by the Ohio Department of Aging.

This rule is being refiled to clarify reimbursement policy concerning community transition services. Specifically, language is being removed from Table B, Columns 4 and 6; and paragraph (F)(6) has been modified to clarify that a HOME Choice participant who is enrolled on an ODA-administered waiver may use HOME Choice community transition services in lieu of, but not in addition to, the community transition service available through the ODA-administered waiver.
