This rule sets forth the definitions for assistance groups and contains the process for handling fleeing felons. This rule has been updated using plain language. We have also corrected acronyms and typographical errors. All references to "stamps" have been changed to "assistance" and all references to "AG" have been spelled out to "assistance group". The definition and procedure for processing a fleeing felon has been expanded to include all of the steps and to ensure clarity.
