Changes to the rule include replacing the reference to "Workforce Investment Act (WIA)" with the current name "Workforce Innovation and Opportunity Act (WIOA)." Also language was added to paragraph (B)(3) to exclude as income any payment made to an employment and training participant for costs that are reasonably necessary and directly related to participation in the employment and training program.
