This rule is being proposed to implement provisions of sections 3109.172 and 3109.174 under Amended Substitute House Bill 64 of the 131st General Assembly relating to child abuse and child neglect regional prevention councils and submission of regional prevention plans.

This rule sets forth regional prevention councils' operation and regional prevention council members' duties. This rule: provides guidance on child abuse and child neglect regional prevention council meetings including notices, quorums, procedure, minutes and agendas; explains council officers and their duties as well as the creation and operation of council workgroups; outlines council duties along with the form and manner by which councils submit regional child abuse and child neglect prevention plans to the Ohio Children's Trust Fund; and provides guidance on child abuse and child neglect regional prevention council member duties including attending council meetings, serving on council workgroups and assisting with the conducting of comprehensive needs assessments.
