The rule is being revised to include additional definitions for clarification. As transitional control halfway houses do not accept persons convicted of sex offenses or arson, the rule is being revised to exclude them from eligibility.

The rule adds definitions for electronic monitoring and electronic monitoring device. The rule also expand definitions to reflect the supervisory and monitoring duties of halfway house staff. The previous prohibition of persons having a conviction for a sex offense within the past ten years has been changed to ineligibility for any such conviction. Person with convictions for arson or aggravated arson are also no longer eligible.
