Pursuant to the rule, the inmate or inmate's family shall bear the costs of the escorted visit. The costs are to be determined based on the mileage for the individual trip, pursuant to the prevailing mileage compensation rate established by the Department of Administrative Services (currently \$0.37 per mile.) Staff compensation will not be a part of the cost. The cost of compliance with the rule varies with each inmate depending on place of incarceration and destination, and therefore cannot be accurately estimated.
