Pre-admission screening and resident review (PASRR) for nursing facility applicants and residents with serious mental illness.**RULE SUMMARY**

This rule is being proposed to replace the rescinded version of this rule. The new 5122-21-03 has been reorganized and restructured to achieve greater clarity and understanding, and to be more accessible to the public. In addition, the rule describes the process of Pre-admission screening and resident review for nursing facility applicants for individuals with serious mental illness.

This rule sets forth pre-admission screening and resident review requirements for individuals with serious mental illness and any prohibitions associated with the pre-admission or resident review screening requirements. Criteria must be met by an individual to either become a new admission or to remain in a nursing facility.

The Department will be required to begin tracking individuals being admitted to nursing home facilities through the hospital exemption, and we will need to create a new position to implement the new requirements. The belief is that the large number of younger individuals admitted through the hospital exemption increases state costs, but the lack of data makes us unable to track this. The long term expected impact is to have better data to guide future policy to increase efficiencies, and control costs.

75% of the salary cost of the new position is reimbursed by the federal government. \$15,575 represents the 25% of the salary that will not be reimbursed and is the responsibility of the Department.

There is no known impact. The rule requires an individual who enters a nursing facility through the hospital (convalescent) exemption to be referred to the local county board of mental health for discharge planning assistance and services if applicable. This requirement, however, already exists in the currently effective rule.
