This rule requires agencies to develop an incident reporting system. It requires that

incident reports be completed and submitted to and reviewed by the agency's executive director/designee. It requires that incidents be included in agency quality assurance activities. It requires the submission of a copy of all major unusual incident reports to the agency director and the community mental health board within 24 hours after the event occurs. And it requires that the agency receive and review all major unusual incident reports from licensed residential facilities regarding persons served by the agency.
