As part of this process MHAS has focused on updating content to be consistent with current practice and wherever practical remove the distinctions between mental health (MH) and alcohol and other drug services (AOD)/substance use disorder (SUD). This work is also being done in conjunction with the Ohio Department of Medicaid Behavioral Health Redesign project, and changes to service rules have been made
