The Peer Support office has been working through the LEAN Ohio process. Out of that process came improvements to the applications for both initial and re-certification for peer supporters. The application has removed a great deal of redundancy and created a single form to be used for applying to be a peer supporter and for the peer supporter training. Prior to this applicants were entering the same information in multiple places. Additionally, a simplified form has been created to allow for applicants who are using the work experience option to submit their work history. These improved forms do not ask for new information, they are just more efficient and customer friendly. The forms have been attached the rules replacing the previous form. No change was made to 5122-29-15.
