Adjunctive therapy service.

(A) "Adjunctive therapy service" means interventions using a variety of media and activities to develop or maintain social or physical skills.

(B) Adjunctive therapy service includes interventions using a variety of media such as art, dance, music and recreation to develop or maintain social or physical skills. Such interventions shall be developed and reviewed as part of the ISP.

~~(C) Services shall be provided by staff qualified according to paragraph (E) of this rule.~~

~~(D) Adjunctive therapy service shall be provided by staff who are qualified by professional standards in the particular field and who are registered or certified by the appropriate state or national body, or who have equivalent education and/or experience.~~

~~(E)~~(C) Adjunctive therapy service shall be provided and supervised by staff who are qualified according to rule 5122-29-30 of the Administrative Code. The following identifies those individuals who are eligible to provide and supervise the adjunctive therapy service. Licensed, certified or registered individuals shall comply with current, applicable scope of practice and supervisory requirements identified by appropriate licensing, certifying or registering bodies:
