All additional consumer outcomes and fidelity review requirements were rescinded. The rule allows more flexibility in determining staff development needs, training schedule and supervision. The eligibility requirements to receive the service were modified. The need to develop a crisis plan is now based on clinical need. There is more flexibility in the amount of hours providing the service/week. The description of the service was revised.
